Chapter Announces 2010 Scholarship Program

The Mid-Florida Chapter announced the launch of its 2010 Scholarship Award program. In January, the HFTP Mid-Florida Chapter began the process through communications sent to several area Colleges and Universities.

The program will award a \$1,000 scholarship to students enrolled in an Associates or Bachelor degree program with a major or concentration in accounting, MIS or hospitality management at an accredited institution of higher education with at least one semester or quarter remaining after the scholarship is awarded. Applicants must demonstrate interest in a career in hospitality accounting, hospitality MIS or hospitality management through an essay of 250 words or less, provide references and have earned a cumulative GPA of at least 3.0 on a 4 point scale.

The deadline for completed 2010 Scholarship applications is March 1, 2010. The Scholarship Committee will make its recommendation for the recipient at the April Board meeting, after which the Scholarships will be presented at the Chapter's April dinner meeting.

The Year was 1986

Known then as the International Association of Hospitality Accountants

Dinner meeting dues at the beginning of the year were \$12.00 for members and \$15.00 for guests - if you prepaid the full year, it worked out to \$10.00 per dinner meeting. By the end of the year, the cost for members rose to \$15.00 and \$18.00 for non-members – prepays remained the same. The yearly membership dues were \$25.00 for the local chapter, and \$50.00 to IAHA. The cost of mailing out the newsletter was 22 cents.

Scholarship winners were picked at the January board meeting – they were: Lynn Anderson and Scott Smith. They were presented their awards at the February dinner meeting that was held at the Sheraton Twin Towers on 25 Feb 1986.

At the March board meeting, a raffle was suggested as a way to raise money for the scholarship fund, with the grand prize being dinner for two at Arthur's 27. Tickets will be sold for \$2 each or \$5 for three chances. The winner would be chosen at the May General Business Meeting.

The IAHA Technology Conference (known today as HITEC) was held in Atlanta from April 9th until April 11th. The Annual Convention was held in Chicago during October.

The nominations committee was formed at the May board meeting. The committee members were: Ken Kruse, Tom Jamison, Cathy Kitchen, Sue McDonald, and Marianne Socha. The board will make their recommendation at the May General Business meeting.

In the July newsletter it was announced that following the General Business Meeting on July 29th, a short meeting will be held for those interested in forming a "Technology Committee" that will advise and support our member hotels on issues related to hotel technology. Ms. Brenda Parker from the Burroughs Corporation was the guest speaker at that evening's meeting – her topic: Office Automation for Hotels.

In August of 1986, we achieved our first membership milestone: 100 members!
